## **CALL TO ORDER**

The meeting was called to order by Mayor Dewayne Birchfield following the public hearings.

## **ROLL CALL**

Upon Roll Call, the following Board members were **PRESENT:** Tina Baker, Linda Black, Derrick Doehler, and Dewayne Birchfield. **ABSENT:** Delmar Davis. (4/1)

Thereupon, Mayor Birchfield declared the presence of a quorum.

## **APPROVAL OF AGENDA**

Alderman Black made a motion to adopt the April 8, 2025 Board Meeting Agenda as written. The motion was seconded by Alderman Baker.
