MINUTES**

Prior to the start of the regularly scheduled meeting there was a public hearing held concerning the adoption of the annual budget for the fiscal year July 1, 2024 - June 30, 2025.

The Town of Greenback Board of Mayor and Aldermen held a regularly scheduled meeting on Tuesday, May 14, 2024, at the Greenback Community Center in Greenback, TN.

CALL TO ORDER

The meeting was called to order by Mayor Dewayne Birchfield at 7:00 PM.

ROLL CALL

Upon Roll Call, the following Board members were PRESENT: Tina Baker, Linda Black, Derrick Doehler and Dewayne Birchfield ABSENT: Delmar Davis (4/1)

Thereupon, Mayor Dewayne Birchfield announced the presence of a quorum.

APPROVAL OF AGENDA

Alderman Black made a motion to adopt the May 14, 2024 Board Meeting Agenda. The motion was seconded by Alderman Baker.

Upon Voice Vote, the motion PASSED unanimously.

GUEST PRESENTATION

Bree Stinnett presented the Board with a proposal for a bathroom/concession facility built beside the little league field on the Town of Greenback property. Cost and upkeep would be incurred totally by the little league organization.

BOARD COMMENTS

Mayor Birchfield expressed his concern for vandalism of a bathroom facility. If the little league organization wishes to pursue the project, they will need to find out what the setback is and where the Greenback Volunteer Fire Dept. septic field line is. Mayor Birchfield also wished to recognize Willie Franklin who was commended in Peoples Magazine for his efforts in helping veterans in distress.

Alderman Doehler also wished to thank the Lost Vets Organization founded by Willie Franklin for its service to veterans. He also acknowledged the recently resurfaced tennis and pickleball court.

Alderman Black brought to the attention of the Board the speeding down Morganton Rd and her desire for a three-way stop.

David Carter agreed with the speeding issue, but it was happening throughout the Town.

Joy LaForce thanked the Board for standing with the citizens concerning the proposed quarry.

Tom Berry addressed the Board with his frustration with the property next door to his. The property houses various trailers, trucks and equipment in violation of the Town's ordinance.
