MINUTES**

The Town of Greenback Board of Mayor and Aldermen held a regularly scheduled meeting on Tuesday, June 13, 2023, at the Greenback Community Center in Greenback, TN.

CALL TO ORDER

The meeting was called to order by Mayor Dewayne Birchfield at 7:00 PM.

ROLL CALL

Upon Roll Call, the following Board members were PRESENT: Tina Baker, Delmar Davis, Linda Black, Derrick Doehler and Dewayne Birchfield. (5/0/0)

Thereupon, Mayor Dewayne Birchfield announced the presence of a quorum.

APPROVAL OF AGENDA

Alderman Doehler made a motion to adopt the June 13, 2023 Board Meeting Agenda. The motion was seconded by Alderman Davis.

Upon Voice Vote, the motion PASSED unanimously.

Mayor Birchfield informed the Board that CVS pharmacy asked if they could set up a flu vaccination clinic at the community center this fall.
