CALL TO ORDER

The meeting was called to order by Mayor Dewayne Birchfield at 7:00pm.

ROLL CALL

Upon Roll Call, the following Board members were PRESENT: Tina Baker, Linda Black, Derrick Doehler, Delmar Davis and Dewayne Birchfield (5/0)

Thereupon, Mayor Dewayne Burchfield declared the presence of a quorum.

APPROVAL OF AGENDA

Alderman Black made a motion to adopt the June 10, 2025 Board Meeting Agenda. The motion was seconded by Alderman Doehler.
